

11. "SO TO THOSE OF YOU WHO ARE STILL THERE WE SAY AGAIN: GET OUT IF YOU CAN!" ("State of the World" #270, par. 11, 12, 14, 18, 25, 27, 28, 29, 33.)

12. "BUT THE PARENTS RUN THE GOVERNMENTS. MAKE THE LAWS & FAIL TO ENFORCE THEM AS THEY CHOOSE. In order to protect themselves, don't they? So there's no such thing as equal protection under the law, is there? The parents can commit the crimes against their children, crimes which would have been severely punished had they been committed by the children against their parents!"

13. "BUT THE 'CHILDREN' LEGALLY AGED, FULL-GROWN & EVEN MARRIED WITH CHILDREN OF THEIR OWN CANNOT EVEN DEFEND THEMSELVES, nor be protected from their parents' cruelties under the laws of some countries like the U.S. & States like New York, or the lack of enforcement of such laws by prejudiced officials! Is this fair?--No!"

14. "AND NOT ONLY THAT, THE PARENTS TURN AROUND & CHARGE THEIR INNOCENT CHILDREN WITH THE VERY SAME CRIMES WHICH THEY THE PARENTS THEMSELVES HAVE COMMITTED criminally & cruelly against their own children! This is always the Devil's way of accusing God's innocent saints of the sins & crimes of which the Devil's own wicked ones are the most guilty!" ("The Truth--Vs. 112 Official Lies" #317, par. 21, 22, 23.)

15. DAD PROPHETICALLY PREDICTED IN THE ABOVE EXCERPTS OF THE LETTER "ASYLUM", OVER TEN YEARS AGO, that they were going to make what we're doing in changing kids' lives with Jesus as illegal as peddling drugs! This has certainly already been fulfilled to a large extent by the worldwide anti-cult campaign, which has been receiving increasing support from various governments, led by the U.S. Nearly everyone in the family has, at some time or another, had some direct or indirect experience with deprogrammers or irate parents, illegally trying to forcibly stop family members from living their lives for Jesus, to the point of committing them to mental institutions & recently even kidnapping their children.

16. SUCH INCIDENTS WILL PROBABLY INCREASE as the Enemy does his best to try to slow down the wonderful job of witnessing that our family is doing worldwide. The Real War goes on! As Dad mentioned in "State of the World", there is no point in trying to fight these cases legally in a System that is hostile to us, so the only recourse we have when faced with such a situation is to "run for our lives!"

17. OF COURSE, THE BEST WAY TO AVOID change is to delay registering it as long as possible, so that you have time to establish your new ID.



33. "BUY A CAR THAT IS DIFFERENT FROM THE MODEL YOU PREVIOUSLY DROVE, choosing a dull model, avoiding splashy colours & styling. Highway patrols give more attention to red cars--a proven fact! (Ideally your car should have local license plates so that you do not stick out in any way.--Keep it clean & respectable.)

34. AVOID ANY RUN-INS WITH TRAFFIC AUTHORITIES, AS EVEN SIMPLE TRAFFIC TICKETS or faulty lights etc. can cause the powers that be to run a routine check on you. "It is a well known fact that arrests of most cons & fugitives are made in 'circumstances unrelated to their crimes'. Stops for traffic violations are number one amongst such violations." Never carry



your actual address with you in your car, or any other confidential information that might be incriminating in case of a search.

MEMBERSHIPS, SUBSCRIPTIONS

35. "SEVER ALL TIES WITH ANY CLUBS, UNIONS, LODGES OR OTHER ORGANISATIONS to which you belong & become a lost member. Leave these groups 'cold' with a few bucks on the books so that it is not obvious that you are pulling up stakes. Never send change of address forms to

THIS IS NOT TO GET CAUGHT IN THE FIRST PLACE, & to stay at least one step ahead of those who would seek to stop your work. Dad has already written a lot on this subject of security over the years. However, recently, it seems that with the rise of the reactionary right coming to pass, especially in America where most of these atrocities occur, there has been a resurgence of kidnappings, deprogrammings & use of force against family members, which has been tacitly approved by the legal authorities.

18. DAD & MARIA HAVE BEEN VERY CONCERNED ABOUT THIS, & expressed the hope that the following information taken from a book published by a radical publisher, as well as our own experiences, will be of help to those of you faced with hostile relatives, & who are fugitives from injustice, to enable you to better avoid the traps of the system & stay free so that you can continue to serve Jesus as long as possible.

19. AND WHO KNOWS? WITH THE WAY THAT THE WORLD IS GOING, this advice could soon well be vitally important for all of us to heed in the dark days that are almost upon us. "We're going back to the Middle Ages. The Nation & the World are going into the Dark Ages of Anti-Christ, Anti-God savagery. And if we do not hole up in the catacombs beneath Rome & organise a totally new society, we're not going to survive. We have to go underground..." ("Colonisation", No. 1, par. 14.)

20. IN READING & APPLYING THIS ADVICE TO YOUR SITUATION, please bear in mind that although there is much good advice contained herein that can be applied to our daily lives, some of the tactics should only be employed in the case of extreme emergencies. Extreme measures, such as creating false ID etc., should only be resorted to with great prayerfulness, in life or death situations, as if you are not led of the Lord they could create additional problems. We hope that you will never have to use some of these methods, but Dad has so often said: "Better to have it & not need it, than need it & not have it!" Pr. 22:3.

21. REMEMBER THAT YOUR BEST PROTECTION IS THE LORD & that if you are in His Will & staying close to Him, He will guide you in the way that you should go. Psalm 91! Even in Dad's own high security situation, we do our best to make sure that whatever we say to outsiders is the truth, though not always all the truth, & we can testify that the Lord has been with us.

newspaper or magazine subscriptions, but let the Post Office simply return them to the sender as undeliverable after you have gone, & never leave a change of address form with the Post Office itself.

36. "LIFE INSURANCE SHOULD BE ALLOWED TO LAPSE OR CANCELLED, taking the money with you before you split. Don't tip them off as they are notorious gatherers of information, but simply mention that you are changing companies. If you patronise a library & are staying in the same area, start using another library, under a different name.

37. "IF YOU FREQUENT CERTAIN BARBERS, STORES OR RESTAURANTS, KEEP YOUR PRIVATE THOUGHTS FROM BECOMING POPULAR KNOWLEDGE, as gossip thrives in these places. Talk about the weather or sports so that you don't tip them off as to your impending move.

38. "IF YOU ARE IN A POSITION TO OPEN A P.O. BOX, DO SO, using your 'legal' address to obtain it, as once you have the box, you can move as often as you wish. Another alternative is to employ a mail forwarding service, (often listed in the 'personal' column of newspapers) who are accustomed to acting as a buffer between you & anyone else, whatever your reasons. If you choose to use two different forwarding services, you can route your mail in & out of the country, or from one coast to another, using various code names. Some of these services also employ telex & telephone answering services."

39. IN A FAMILY MEMBER'S CASE, AN EASIER, CHEAPER & MORE SECURE ALTERNATIVE WOULD BE TO USE P.O. BOXES OF VARIOUS HOMES, preferably in a country far away from where you are being looked for & arrange with that home to forward your mail on to you; & to mail letters from you to the "outside" world!

40. "IF YOU ARE TRYING TO SHAKE PARTICULAR PEOPLE, PROVIDE A FORWARDING ADDRESS OUT OF THE COUNTRY--preferably far away--& arrange to have letters from you sent from that country stating that you never plan to return. Another ruse is to write 'deceased' on any mail that you receive & drop it unopened into a public mail box. All but professional snoops will get the hint." (But be careful that you do not leave your fingerprints on the envelope.)

41. "IF YOU HAVE GROWN CHILDREN OR RELATIVES, MAKE IT CLEAR TO THEM THAT THEY WILL NEVER KNOW WHERE YOU REALLY ARE, & correspond through mail drops, pay phones etc. Cutting family ties may hurt, but

& prospered us, allowing us to live & carry on our operations in some of the most "impossible" & improbable situations.

22. SO BE SURE ABOVE ALL TO "TRUST IN THE LORD" & lean not unto thine own understanding. In all thy ways acknowledge Him & He shall direct thy paths." (Pr. 3:5,6.) When you are doing this, you can pray & use "all things" to His glory, (Tit. 1:15, 1Co. 10:2) including the advice on the following pages.

23. "TO LIVE FREE MEANS TO BE ABLE TO CONTROL YOUR OWN LIFE & to avoid violence or the threat of violence, by others. What you do & how you do it will almost always determine whether or not freedom will be yours. But you must take the responsibility for creating your own freedom.

24. "TO 'DISAPPEAR' MEANS TO MAKE IT IMPOSSIBLE FOR OTHER PEOPLE TO INVADE YOUR PERSONAL WORLD OF FREEDOM. Since most such invasion is by means of electronic data gathering & cross-referencing, you must be able to short-circuit these procedures effectively. Thanks to computers & credit cards, virtually everyone has lost his privacy. Resorting to methods of disappearing are really the only feasible ways of evading what amounts to electronic control of your life."

25. THE AUTHOR ADVOCATES THAT THE MOST EFFICIENT WAY OF DISAPPEARING IS TO ESTABLISH AN "ALTERNATIVE IDENTITY", allowing you to "disappear" & be "reborn" at will. This enables you to leave your past record behind, a record which by incrimination can often condemn you to a life of second rate opportunity & social ostracism (such as someone who has been dishonourably discharged from the military, served a jail term, or is a known religious fanatic!)

26. "IT BECOMES EASILY UNDERSTANDABLE WHY SUCH A PERSON SHOULD BE WILLING & ANXIOUS TO SCUTTLE HIS LABELED IDENTITY & take on another. The object is for individuals, acting as individuals, to declare their mental independence from whatever system is attempting to enslave them. For example many draft dodgers fled to Canada during the Vietnam debacle & were subsequently able to return to the U.S. with good alternate ID."

27. THE AUTHOR DOES EMPHASISE THAT THERE ARE NUMEROUS INTERMEDIATE TACTICS BETWEEN TOTAL COMPLIANCE WITH THE SYSTEM & COMPLETE DISAPPEARANCE. Such as: changing names, changing addresses, changing appearance, etc.

more. Children should be taught not to divulge information to strangers, & agents should be told to 'get a warrant'."

42. "IF YOU NEED TO MOVE LARGE AMOUNTS OF PERSONAL PROPERTY", (you shouldn't--we're pilgrims & strangers!) "arrange for a professional mover from out of town to move your stuff to a public storage warehouse where only you have access to it. Then, months later, arrange for another mover to transfer your goodies to your new address at a time when surveillance is apt to be minimal. Avoid visits to check up on your possessions, & give an alias to the storing agent." Another alternative is to rent a private storage garage, such as are in unguarded garages & where you have access 24 hours a day.

43. "IF YOU SHIP PERSONAL PROPERTY THROUGH A COMMON CARRIER, have them send it to one of their pickup points reasonably near your new location, telling them that you have no definite new location as of yet, & that you will call for it. Then, collect the goods, & repeat the procedure, using a different carrier, to a destination closer to your location, & collect the goods again."

44. "IF YOU DECIDE TO SELL YOUR POSSESSIONS" (by far the most practical solution!) "BE SURE NOT TO BETRAY YOUR REAL REASONS FOR DOING SO (You could be going into missionary work in Uruguay--ha!) nor your destination. You could pose as an employee of the person moving, & that the boss is moving to another state."

45. "IF YOU DECIDE TO SELL THINGS TO A PAWN SHOP, be discreet, as pawnshops are natural haunts for snoops, & pawnshop operators are very astute observers of people, sensing desperation, even before you come in the door."

46. "NEVER BECOME OVERLY FRIENDLY WITH THE LANDLORD. Hold up your end of the rental agreement & he will undoubtedly be pleased to leave you alone. Snoops love to question landlords, so consider every conversation with them the same as if you were talking to the FBI." Familiarity breeds contempt!--So keep a polite but formal relationship with him!

47. "IN LEAVING YOUR OLD DIGS, you can always give vague allusions to your landlord of going back east, or going to college. Never let them know where you're really going."

48. "WHEN YOU CHANGE HOUSES OR APARTMENTS,

taining several foreign citizenships & passports, setting up bank accounts in several other countries & planning at least two routes of escape to other countries etc.

28. HE ALSO STRESSES HOW EACH INDIVIDUAL MUST EVALUATE HIS OWN SITUATION, & use whatever methods he feels are appropriate to secure & maintain his personal freedom. He further warns that, "We make no claims of completeness or of exhausting the subject, as that could be potentially dangerous were individuals to rely solely on this information."

29. "A CARDINAL OPERATING PROCEDURE IS TO NEVER ESTABLISH A LINK BETWEEN THE NEW & THE OLD. Use blind addresses, aliases & other covers to screen any transitions that might involve your past. Time delays work well in your favour, the longer the better."

30. CARS: "IT IS GENERALLY POSSIBLE TO TRACE A PERSON THROUGH HIS VEHICLE REGISTRATION, so be sure not to send in a change of address if you plan to disappear. When it comes time to pay registration fees, either sell the car outright, or arrange to sell the car to your new ID, which can often be done through the mail. (Countries such as Britain have a master computer in which is stored vital information on each registered car owner.) Your driver's license is also an easy way for anyone to learn about you, a copy of which any investigator has no difficulty in obtaining."

31. "THERE IS A NATIONAL CLEARING HOUSE FOR VEHICLE REGISTRATIONS, which means a particular vehicle, if properly registered, can be traced through its various sequential owners. It would be a shame that one's love for his car were greater than for his personal freedom. Registering the car in the name of a business would be another ploy to consider, or a two stage dummy sale, especially if one of the transactions took place in another state. The registration of all personal property such as caravans should be considered in the same light."

32. "IF YOU DECIDE TO SELL YOUR CAR, SELL IT YOURSELF TO A PRIVATE PARTY FOR CASH, being sure not to reveal any vital information to the buyer, who could later be questioned by 'snoops'. On the contrary, this would be an ideal place to dump any car that you don't want to be traced by anyone."

49. "WHEN LEAVING YOUR OLD LOCATION, NOTIFY THE UTILITIES & TELEPHONE COMPANY TO DISCONTINUE SERVICE, if they are in your name, telling them not to send any refunds or closing bills until you notify them, as you are not yet sure of your new address. This way you will not leave any leads in this fertile field for investigators. If you plan to stay in the same general area, begin these utility services in your new dwelling several weeks before or after you move, as snoops would connect requests within five to ten days of your new move & investigate them."

50. "IN LOOKING FOR NEW ACCOMMODATION, CHECK THE PAPERS FOR ADS UNDER HEADINGS SUCH AS 'ROOMS TO SHARE', 'Apartments to share' etc. By sharing an apartment with someone who already has all the utilities in their name, you avoid having your name appear on any rental papers, as well as not having to deal directly with a landlord. This is a great way to 'get lost' & leave your old identity behind."

51. CONCERNING DWELLINGS, WE WOULD RECOMMEND THAT A GOOD SOLUTION IS TO RENT SHORT TERM FURNISHED & EQUIPPED HABITATIONS. These generally require less registration, & often, if you look presentable, the owner or agent will not even ask you for identification, allowing you to use an alias."

52. OTHER ADVANTAGES ARE THAT THE PHONE & UTILITIES ARE ALREADY INSTALLED IN THE OWNER'S NAME, & in some cases you can even receive mail in the absentee landlord's name, allowing you to live virtually anonymously. If you rent short term, you can avoid potentially embarrassing questions such as where you work, or if you have a visa, as it is perfectly understandable to be a tourist on vacation for a few months."

53. WHEN DEALING WITH YOUR NEW LANDLORD OR REAL ESTATE AGENT, TRY TO USE AN ALIAS IF POSSIBLE, as agents could be a give-away to any snoop who knows the general area in which you are living". However, often you are asked for ID, so be careful & prayerful. "Once you have your new accommodations, always pay your utility bills
