101. "IF YOU LIVE IN A HOTEL, MOTEL, OR NOSEY APARTMENT COMPLEX, always make it a point to be ordinary & outwardly polite to any employees on the premises. Give them no reason to remember you other than as a normal person, as freaky behaviour is easily noticed & remembered by telephone operators, janitors, maids, superintendents, etc., & tips can make them talk.

102. "ALSO REMEMBER THAT THERE ARE SOME PEOPLE THAT HAVE NOTHING BETTER TO DO THAN TO SPY ON THEIR NEIGHBOURS, & can easily become very familiar with your daily routine, the hours you keep, the car you drive etc. & report any suspicious behaviour to your landlord or the authorities. To avoid such surveillance try to use different entrances to your apartment building, & don't park in front of it.

103. "ALONG THIS LINE, MAKE IT A POLICY OF HAVING AS FEW VISITORS AS POSSIBLE, especially anyone who might have a suspect appearance, & raise doubts in your neighbours eyes as to the company that you keep. Remember, it's easy for a friend to give you away innocently, so arrange get-togethers elsewhere & 'keep your nest clean'!"

#### 10021 PUBLIC BEHAVIOUR/LIFESTYLE

104. "IN GENERAL, IN ADAPTING TO YOUR NEW LIFE, EXAMINE YOUR DAILY HABITS & ELIMINATE ANY WHICH MIGHT BE REGARDED AS 'PECULIAR' ESPECIALLY IF PERFORMED PUBLICLY. Dress conventionally, adapting what you perceive as the community standard. Blend in, & become one of the many shades of grey, not black or white. Conformity to the norm generally means clean & neat, neat beard, if any, no long hair, freaky clothes ('biker' colours are out) or other showy, gaudy convention flaunting attire.



105. "AVOID DRAWING ATTENTION TO YOURSELF BY EXHIBITING SOCIALLY UNACCEPTABLE

BEHAVIOUR PUBLICLY. Even perfectly legal behaviour, such as solitary walks late at night or wearing clothing inappropriate for the weather can arouse suspicion. Cops are programmed to bust anyone who appears different (from them). Never express controversial opinions around home or at work. If you preach, do it in another state, or town.



106. "AVOID ATTENDING CHURCH, BUT IF YOU MUST, USE AN ALIAS & DONATE IN CASH. If neighbours ask which church you attend, deny interest or give one of a different faith from theirs. Beware of ministers, as they are great gossips when approached by snoopers."

#### QUESTIONS

107. "AS MENTIONED ABOVE, YOUR APPEARANCE, POSSESSIONS & ACTIONS SHOULD ALWAYS JUSTIFY YOUR APPEARANCE ON A LEGITIMATE, CONVENTIONAL BASIS as this is the best way to avoid suspicion. However, if you are asked questions, whether by individuals or the authorities, always be able to give an explanation of why you are there, where you are from, & where you are going. Smile & be helpful. Have conventional answers to common questions such as where you are from, where your family lives etc., but be vague.

108. "IF INDIVIDUALS ARE OVERLY INQUISITIVE, you are better off in telling plausible half truths than countering with an awkward silence. It's perfectly moral to mislead someone who is asking questions that are none of his business, as he is the one that is acting immorally. The object is to avoid suspicion & appear 'reasonable'. Remember that this is not illegal unless you are under oath. And if someone persists in asking questions that are obviously none of his business, tell him a few out & out evident lies that will make him look like the ass that he obviously is.

109. "TRY TO AVOID ALL CONTACT WITH LAW ENFORCEMENT AGENTS, AS THEY ARE LIKE SPONGES, taking in endless bits of information. AVOID TROUBLE & AVOID COPS. If you

#### TELEPHONE

127. "IF SOMEONE IS TRYING TO LOCATE YOU, THEY MIGHT INVITE YOU TO CALL THEM PERSON-TO-PERSON COLLECT. DON'T DO IT, as they are really after your location, which they can obtain through the operator after the call is over.



128. "PROTECT THE NAMES, ADDRESSES & TELEPHONE NUMBERS OF YOUR FRIENDS by using a code to disguise the actual names & numbers, or memorise them. Try to avoid carrying this coded address book with you, as many 'rings' are busted in this manner. Carry instead a false notebook filled with numbers & addresses that you have chosen at random from various phone books. Keep your 'working' book in a safe place. This will also protect you, inasmuch as suspicion is cast on you if some of your friends are busted & their names appear in your book."

#### JOBS

129. "BEWARE OF ANSWERING 'PERSONAL' ADS IN NEWSPAPERS AS WELL AS JOB OFFERS THAT ARE TOO NEATLY TAILORED to the type of work that you did before disappearing. Disregard them if they call for replying to a box number, & only reply to them if they do not involve giving yourself away, such as offers at known companies. Call these numbers only from pay phones, so that in the event that it is an investigator trying to smoke you out, he will not be able to trace you.

130. "ONCE YOU ARE ON THE JOB, AVOID GIVING BACKGROUND INFORMATION TO FELLOW WORKERS, & only give them deliberately misleading information as to your hobbies, future plans etc. Insulate your private self by keeping your personal in-

are not obliged to talk to them but whatever you do say to them must be the truth, as it is generally illegal to make false statements to a law officer.

110. "IF YOU SENSE THAT THINGS ARE NOT GOING YOUR WAY, suggest to the officer that he take the matter up with your attorney, providing him with his name & address. This will let him know that you are aware of your rights, & that if he wants to push the matter further he will have to take you to court.

111. "A SULLEN OR HOSTILE ATTITUDE triggers the cops for a bust--your bust. So go ahead & kill them--with kindness. You'll win by keeping your freedom.

112. "WHATEVER YOU DO WHEN FACED WITH QUESTIONS OR HARASSMENTS, FROM INDIVIDUALS OR OFFICERS, DON'T BLOW YOUR COVER & LEAD THEM TO SUSPECT YOU. Keep your temper, be humble & polite & refrain from shouting matches &/or slugfests. Remember that you are a minority of one, & that 'they' still have the guns & bars. If you are not content to let 'vengeance be the Lord's' don't let the enemy determine your tactics, but rather retaliate at a time & place of your choosing."

113. "FURTHERMORE, IF YOU EXPECT OTHERS TO RESPECT YOUR PRIVACY, you must extend the same courtesy to them & refrain from asking them personal questions. Not only might they resent your questioning, but it leaves you open to the same questions being asked of you. Don't ask people questions that you wouldn't want them to ask of you. Your attitude should be that personal information such as background, origin, interests, politics, family income are no ones business but your own.



114. "IN YOUR NEW LIFE, YOU WILL WANT TO AVOID AT ALL COSTS BEING FINGERPRINTED, so stay clear of demonstrations or dissent activities that might lead to mass arrests. This also holds true in applying for jobs that require the fingerprinting of personnel."

115. "IN SOME STATES, TO CONVINCE THE

interests & ideas to yourself alone. Share the spurious with the curious."

#### LEGAL/BANKING AFFAIRS

131. "AVOID USING BANKS EXCEPT FOR ACTUALLY CASHING CHECKS GIVEN TO YOU BY OTHER PEOPLE, for example your employer. If you are paid by cheque, don't deposit the paycheck in an account with your name on it, but take it to the bank that it is drawn on & cash it there. Vary the days & hours that you visit the same bank, & if possible avoid becoming too well known or familiar by any one teller or at any one branch.

132. "TRY TO CONDUCT YOUR AFFAIRS AS MUCH AS POSSIBLE USING CASH OR MONEY ORDERS. Cash still has no names on it, which is why big brother can hardly wait for the day of the cashless society. When using money orders, never write your name on the face or the line marked payer, but use an alias. For most purposes, money orders can be considered untraceable as they are often filled by number only, & not by name. The are generally very useful in disguising financial dealings, as most people consider them the same as cash, & virtually never record the number.

133. "KEEP YOUR NAME OUT OF PUBLIC RECORDS, such as business licenses, permits, tax accounts etc., & operate under another name or use another person as a front.

134. "FOR MOST TRANSACTIONS, DON'T REQUEST A RECEIPT UNLESS THE AMOUNT IS LARGE & then make it only intelligible to the parties concerned. One caution in your transactions: Most banks have an established policy of recording the serial no. of bills of large denominations when they are deposited or withdrawn in large amounts, & all transactions of over \$10,000 are reported to the IRS. SO PLAY IT SMALL & REMAIN INCONSPICUOUS."

#### MEDICAL

135. "WHENEVER YOU NEED THE SERVICES OF A PHYSICIAN, DENTIST, HOSPITAL ETC., make it a standard practice to use an alias & a different address, from where you are actually staying, & pay in cash. Any information concerning your driver's license number should be false. Medical records are definitely not confidential & we have never heard of anyone getting busted for giving false information who paid their bills. If you need to have prescriptions filled often, be sure to visit several different pharmacists, & never give your correct name & address."

#### TRANSPORT

136. "DON'T TAKE THE BUS CROSS COUNTRY

SENSE, but is not mandatory. If this is the case, you can decline to give it, claiming that it violates your basic religious beliefs, or that fingerprinting is just another part of the International Communist Conspiracy (look the bureaucrat straight in the eyes with this one, after a quick paranoid glance over your left shoulder).

116. "AVOID MEMBERSHIP IN POLITICAL GROUPS OR OTHER CIVIC ORGANISATIONS as they are often filled with sneaky nosy individuals ready to stab someone in the back if it suits their purpose. Total snakes."

#### MAIL

117. "IT IS OF THE UTMOST IMPORTANCE THAT ANYONE WISHING TO DISAPPEAR MUST LEARN HOW TO BE VERY CAREFUL WITH THEIR MAIL. THINK BEFORE ACTING!"

118. "FIRST OF ALL, ARRANGE TO HAVE YOUR MAIL SENT TO A 24 HOUR POST OFFICE BOX OR MAIL FORWARDING SERVICE. This way, the only mail that you will receive at your residence will be the 'occupant's' variety, or junk mail. NEVER ACCEPT REGISTERED OR CERTIFIED MAIL, simply tell the mailman that you are not the person named on the receipt.

119. "IF YOU NEVER RECEIVE PERSONAL MAIL AT YOUR ADDRESS, THE MAILMAN WILL NOT KNOW YOUR NAME. Be polite & courteous & simply help him to do his job by telling him that there is no such person living at your address. If he asks who you are, he's out of line. He will thus return it to the sender marked 'unknown at this address'."

120. "PROVIDING ANY OTHER INSTRUCTIONS OTHER THAN RETURN INSTRUCTIONS CAN INVITE DISASTER. Even putting on a fake forwarding address will tell the sender, when the letter eventually comes back to him, that someone at that address knows more than he does. You can then expect more registered letters, surveillance, or a personal visit.

121. "REMEMBER THAT TRACING BY MAIL IS THE CHEAPEST ROUTE FOR SNOOPERS, so be on the lookout for any mail that you're not expecting or that seems the least bit suspicious, as it could be the opening salvo in an attempt to determine your whereabouts. Watch your mail!!! ANY SUSPICIOUS OR UNFAMILIAR MAIL WITH YOUR NEW ADDRESS SHOULD SIMPLY BE MARKED 'UNKNOWN, RETURN TO SENDER' AND DEPOSITED IN A PUBLIC MAIL BOX FOR RETURN."

122. "BEWARE OF NOTORIOUS HANGOUTS for informers who appraise bus travellers as only 'niggers, spics, beatniks or other commie types.'"

#### CONCLUSION

137. "WE HOPE THAT THIS IS A HELP TO YOU WHO ARE CAUGHT IN THESE SITUATIONS. As Dad has often emphasised, the best security is preventative security, when you are alert enough & close enough to the Lord to foresee such possible dangers, & take measures to avoid them before such drastic corrective measures will be necessary. Sometimes these situations arise when we let down our defences--the deadly unguarded moment!"

138. "IF THE DEVIL CAN'T GET YOU TO STOP, HE TRIES TO GET YOU TO COMPROMISE. He tempts you with half truths that make you doubt your convictions or not live up to them fully. He knows you'll never make peace with him in your war on evil, so he tries to tempt you with a temporary truce.

139. "IF HE SUCCEEDS IN GETTING EVEN A SHORT CEASEFIRE he has time to bring up reinforcements, encircle you, infiltrate you with his lies & spies & try to trap you completely! You can't do business with the Enemy even for a moment! He's out to win!"

140. "AND THE ONLY WAY HE CAN WIN IS TO GET YOU TO LET DOWN YOUR GUARD FOR JUST A MOMENT so he can get in, or compromise only a few minutes so he can do his dirty work while you're not looking!"

141. "THE ENEMY OF YOUR SOUL JUST NEEDS A LITTLE TIME OF COMPROMISE TO GET CLOSE enough to strike you some mortal blow below the belt in his wicked war of weaseling his way in so that you're knocked out before you know what hit you! This is the grave danger of the unguarded moment!--Just a moment of unguarded danger that can put you in your grave!"

142. "ARE YOU PLAYING FOOTSY WITH THE DEVIL & HIS CROWD?--Let me warn you: he plays for keeps! And any compromise with his tactics can bring a disaster that could result in total surrender!--Don't give him an inch or he'll take a mile--or more & everything you've got!"

143. "DON'T LET IT HAPPEN TO YOU! RESIST THE ENEMY & HE WILL FLEE FROM YOU! Don't even let the ol' camel get his nose in or he'll soon have the entire tent! Give no place to the Evil One! Hallelujah!
